RESOLUTION DECLARING THE INTENT OF THE VILLAGE BOARD OF THE VILLAGE OF WAPPINGERS FALLS TO ACT AS LEAD AGENCY FOR SEQRA REVIEW IN CONNECTION WITH CONTRACT 5 – WATER CONNECTION TO THE TOWN OF WAPPINGER

The following Resolution was introduced by Trustee Davis and seconded by Trustee Komornik.

WHEREAS, in 2016, the Village of Wappingers Falls undertook various utility improvements known as Contract 4, and the Village Board was declared Lead Agency for the purposes of SEQRA; and

WHEREAS, it is the intent of the Village Board of the Village of Wappingers Falls to assume the role of "Lead Agency" for purposes of conducting a SEQRA assessment for Contract 5, which consists of a water connection to the Town of Wappinger in accordance with an Intermunicipal Water Supply and Transmission Agreement with the Town of Wappinger dated July 24, 2019; and

WHEREAS, Part 1 of a Full Environmental Assessment Form (FEAF) has been completed for the Project, reviewed by the Village Board of the Village of Wappingers Falls, and will be circulated to all Interested and Involved Agencies for purposes of establishing the Village Board of the Village of Wappingers Falls as "Lead Agency" in accordance with 6 NYCRR Part 617.6(b); now, therefore

BE IT RESOLVED, that the Village of Wappingers Falls will send said Part 1 of the FEAF to the Interested and Involved Agencies under cover of a "Notice of Intent to Establish Lead Agency" letter for purposes of establishing Lead Agency status under SEQRA; and

BE IT FURTHER RESOLVED, that the Village Clerk and Village Attorney are hereby authorized to take all actions, serve all notices, and complete all documents required to give full force and effect to this determination.
